OROVILLE'S GOT TALENT - RULES OF ELIGIBILITY AND PARTICIPATION

- 1. Divisions:** Entries must select either Youth Division (ages 18 & under) or Adult Division (ages 19 & older). For group performances, the age of the eldest member will determine the division.
- 2. Time Limit:** Acts are permitted four (4) minutes to complete the performance. A penalty of ten (10) points for each minute or fraction of a minute exceeding the four-minute limit may be imposed by the Timekeeper. Introductory music begins the time. Once the act begins, the clock will not stop for props, changes, or resets.
- 3. Accompaniment:** Recorded accompaniment may not predominate over the contestant's performance. For example, a vocalist may not use a recording with a lead singer as accompaniment in a way that makes the contestant a duet with the recording.
- 4. Safety Restrictions:** Baton twirling, juggling, trampoline, swords, knives, guns, pyrotechnics, fire, or other dangerous props or effects are not allowed.
- 5. Rehearsal/Tryouts:** Rehearsal/Tryouts will be held Tuesday, September 8, 2026, from 4:00 p.m. to 6:00 p.m. Participants should arrive prepared with required music, props, and any setup needs.
- 6. Performance:** The performance will be Saturday, September 12, 2026. The Youth Division begins at 6:00 p.m., followed by the Adult Division.
- 7. Media Release:** The Exchange Club of Oroville reserves the right to record, photograph, copy, publish, distribute, and use performances and related event recordings for purposes including promotion, archives, and fundraising for the Exchange Club of Oroville and the Oroville's Got Talent / Search for Talent program.
- 8. Final Decisions:** The Exchange Club of Oroville reserves the right to determine eligibility, division placement, performance order, and rule compliance. Failure to comply with these rules may result in elimination of the act.
